Because of our gracious donors, we were able to continue construction of our second school, Hayden. Specifically, despite the Health Crisis and related construction delays and cost increases, we were able to substantially complete construction activities in an area with a significant number of children who are unable to attend school. In fact, the closest school, a private institution, is unaffordable and the other nearest school is several hours away. Ultimately, we are expecting 350 to 400 students to enroll 2021 Q2 or Q3. Our goal is for education to be the means through which the people of this area can/will further the development of their community.

Again, due to our gracious donors, the Health Crisis was not a significant obstacle for Nahla Operations. Fundamentally, in 2020, we continued to close the education inequity gap as we moved to provide access to safe, socially distanced, in-person education for the more than 400 children. Without this support, these children would not have been able to experience the life changing opportunity of education and would be at high risk for never returning to school.

And finally, as we noted in prior statements, with Hayden substantially complete, we have begun readying the school for 2021 Q2 or Q3 operational opening.
